This is in continuation of our earlier disclosure dated April 16, 2025, made pursuant to Regulation 30 of the Listing Regulations, regarding receipt of a Provisional Attachment Order dated March 31, 2025 by Dalmia Cement (Bharat) Limited ("DCBL"), a material wholly owned subsidiary of the Company, from the Jt. Director, Enforcement Directorate ("ED"), Hyderabad, regarding provisional attachment of land of DCBL.

In this regard we would like to update that the Adjudicating Authority under the Prevention of Money Laundering Act, 2002, vide its Order dated September 22, 2025 (received by DCBL on September 23, 2025) has confirmed the aforesaid Provisional Attachment Order dated March 31, 2025. However, consequent to above order, there is no impact on the day-to-day operations of DCBL.

DCBL is examining the aforesaid Order and basis legal advice, will take further steps to pursue appropriate legal remedies assailing the impugned order before appropriate forum.

The details as required under Regulation 30 of the Listing Regulations read with SEBI circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13,2023 are provided in the Annexure hereto.
