* Pursuant to the order dated April 12, 2018, the National Company Law Tribunal approved a scheme of amalgamation and arrangement which provided for (a) merger of Ankita Pratisthan Limited (Ankita), Mayuka Investment Limited (Mayuka), Puneet Trading and Investment Company Private Limited, Zipahead.Com Private Limited, Mahanadi Trading Private Limited and Shreevallabh Textile Private Limited with Rama Investment Company Private Limited (Mayuka), Puneet Trading Private Limited (Seshav) and Shree Nirman Limited (SNL) into Rama Investment Company Private Limited (Rama) ("Scheme"). However, the aforesaid Scheme was set aside by the National Company Law Appellate Tribunal ("NCLAT") by its order dated November 29, 2019 ("NCLAT Order") and the application of the said order was also rejected vide order dated September 17, 2021. Further, an appeal was filed with the Hon'ble Supreme Court on 23rd December 2021 against the NCLAT Orders to the extent NCLAT has set aside the Scheme with respect to amalgamation of Private Companies involved in the scheme. Hon'ble Supreme Court vide order dated 07th September, 2022 has disposed off the matter by setting aside the order of NCLAT dated 29th November, 2019 and confirmed the Scheme as approved by the NCLT in respect of four Private Companies with Rama. The shares belonging to Keshav and SNL have since been transferred back by Rama pursuant to reversal of demerger. However, shares belonging to Ankita and Mayuka pursuant to reversal of merger are yet to be transferred back by Rama pending opening of their demat accounts. Accordingly, the above shareholding of Rama has been provided giving effect as above.
