* Pursuant to the order dated April 12, 2018, the National Company Law Tribunal approved a scheme of amalgamation and arrangement which provided for (a) merger of Ankita Pratishan Limited (Ankita), Mayuka Investment Limited (Mayuka), Puneet Trading and Investment Company Private Limited, Zipahead.Com Private Limited, Mahanadi Trading Private Limited and Shreevallabh Textile Private Limited with Rama Investment Company Private Limited; and (b) demerger of cement business of Keshav Power Limited (Keshav) and Shree Nirman Limited (SNL) into Rama Investment Company Private Limited (Rama) ("Scheme"). However, the aforesaid Scheme was set aside by the National Company Law Appellate Tribunal ("NCLAT") by its order dated November 29, 2019 ("NCLAT Order") and the application for modification of the said order was also rejected vide order dated September 17, 2021. Further, an appeal was filed with the Hon'ble Supreme Court on 23rd December 2021 against the NCLAT Orders to the extent NCLAT has set aside the Scheme with respect to amalgamation of Private Companies involved in the scheme. Hon'ble Supreme Court vide order dated 07th September, 2022 has disposed off the matter by setting aside the order of NCLAT dated 29th November, 2019 and confirmed the Scheme as approved by the NCLT in respect of four Private Companies with Rama. The shares belonging to Keshav, SNL, Ankita and Mayuka have since been transferred back by Rama pursuant to reversal of demerger/merger. Accordingly, the above shareholding of Rama has been provided giving effect as above.
